- 5) NET/ SLET/ SET shall also not be required for such Masters Programmes in disciplines for which NET/ SLET/ SET is not conducted.

Important Information for Applicants

1. The process of recruitment and appointment on the posts advertised shall be as prescribed under the Statutes and Service Rules of the University.

7. Envelope containing application should be superscribed as “Application for the post of (Name of Post) for (Name of the College/ Institute)”.
8. No T.A./ D.A. will be paid to the candidates called for interview/ test.
9. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received in response to the advertisement is large and it may not be convenient or possible to interview all the candidates, the University, at its discretion, may screen the applications and shortlist the candidates on the basis of qualifications, experience, publications etc to be called for the interview. For this purpose, the University may constitute a screening committee to scrutinize the applications to short list the candidates. For the Posts of Assistant Professor, the University may also hold written/ qualifying examination for short listing the candidates for interview.

The topic for presentation of maximum 5 minutes duration may be related to the subject concerned, and may be chosen by the candidate. The written test, if given, will include subject related questions, and will be of maximum two hours duration.

Note 1: The parameters listed in table of category-III (Research and Academic contributions) shall have following capping in relation to the total API score claimed by the candidates:

Note 2: The minimum API scores for the posts of Associate Professor and Professor are 300 points and 400 points, respectively, from Category II & III of API.

Note 3: It is incumbent on the Coordination Committee proposed in these Regulations and the University to prepare and publicize within six months subject-wise lists of journals, periodicals and publishers under categories III A and B. Till such time, screening/selection committees will assess and verify the categorization and scores of publications.

Note 4: The self assessment score will be based on verifiable criteria and will be finalized by the screening/ selection committee.

Note 5: The API score for paper in refereed journal would be augmented as: i) paper with Impact factor less than 1 – by 5 points; ii) impact factor between 1-2 –by 10 points; iii) paper with Impact factor between 2-5 by 15 points; iv) paper with Impact factor between 5-10 by 20 points; v) paper with impact factor above by 10- 20 by 25 points. The points for research papers in refereed journals should be calculated based on the Impact Factor of the journal and its equivalent NAAS/ other current ratings.

Note 6. The API for joint publications shall be calculated in the following manner: - Of the total score for the relevant category of publication (research papers/ books/ book chapter etc) by the concern teacher, the first/ Principal/ corresponding author/ supervisor/ mentor would share equally 70% of the total points and the remaining 30% would be shared equally by all other authors.
